An elector spoke on agenda item PL/045/15, giving the reason that the Bude Canal and Harbour Society would have for objecting to any future application made for a filtration system to discharge 'grey water' into the canal.

An elector raised concerns regarding the building of 12 Flats in Flexbury ( PA12/11870), the Chairman explained that as this application was passed by Cornwall Council some 3 years previously no more could be done regarding the building of the flats

An elector raised concerns regarding a previous planning application PA14/05169, which Cornwall Council objected to and is now in the process of an appeal. The Admin Assistant explained that BSTC had not had notification of an appeal but would investigate this with the planning officer dealing with the case.

Resolved: That BSTC object to the development on the grounds of overdevelopment of the site and the proposed development is not in keeping with the surrounding area. BSTC note all the concerns of neighbouring residents regarding overlooking issues.

2) **PA15/01337** – retention of campsite, shower block and wind turbine (6m tip height) and provision of 20 tent pitches at Cerenety Eco Campsite, Upton, Bude for Mrs J Moriaty Cerenety Eco Camp Site

# PL/045/15 Matters referred from Environmental Services & Highways Committee 9 April 2015: Electors concerns regarding 'grey water' discharge into Bude Canal

BSTC admin assistant outlined conversations she had had with Officers at Cornwall Council Environmental Services, Coast and Countryside, Marine Services and the Bude Harbour Master regarding 'grey water' discharge in to the Canal. At this time it is not an official application to dispose of 'grey water' into the canal. The owners of the barge/boat restaurant to be moored on the canal have been seeking the advice of the harbour master and Cornwall Council officers, who in turn have said that until an application has been made and the specification of any filtration system has been seen they cannot agree or disagree.

BSTC noted the concerns of Bude Canal and Harbour Society and other Canal users but until an official application has been received the committee could make no comment

The Chairman suspended Standing Orders to speak with electors who wanted to speak on application PA15/02429

The Chairman explained the planning procedure to the electors and allowed discussion to take place for a limited time. The decision of planning committee was re-iterated to the electors and the Chairman then re-instated standing orders
