A member of the public highlighted their concerns re parking in Bude, as per the letter (noted above) that they had sent to Cornwall Council.

C/191/17 **Opportunity for Cornwall Councillors present to discuss Cornwall Council issues relevant to BSTC**
CC Cllr N Pearce: Advised that the 'surfboard' artwork will soon be installed on the roundabout in Bude. The design will ensure that it will not obscure the view across the roundabout.

CC Cllr P La Broy: Spoke regarding the CALC meeting and divisional boundaries, it appears that the numbers would only justify 3 CC Cllrs in the Bude-Stratton area not 4 as is the current number.

Double yellow lines – Cllr La Broy reported that both he and Cllr Pearce had spent several hours discussing the scheme with the person dealing with it. Summerleaze Crescent has a single yellow line at present but that will be made into a double one. The proposed changes should solve many problems. The expected implementation timescale is the end of April 2018.
