On Monday 26<sup>th</sup> October the Town Clerk and I attended a Cornwall Council meeting in Liskeard where Cornwall Council's proposed budget for parking and related matters were outlined. Full details will be circulated on receipt.

Regarding the damage to the flower beds at the Triangle, the offenders were captured on CCTV and apprehended by the police. All were from outside of Bude and its immediate environs. Since a minor was involved their names cannot be published.
