

### **Full Council Minutes**

## Meeting held at 6pm on Thursday 1<sup>st</sup> February 2024 in the Conference Room, Parkhouse Centre, Bude

**Public participation**: The public present commented on the BSTC Council tax precept increase and the Compass Point project.

#### FC/016/24 To receive apologies and accept reasons for any non-attendance

Apologies had been received from Cllrs Goode (personal) and Tame (personal). The reasons were accepted.

### FC/017/24 To receive Declarations of Interest and note any dispensations granted

None received.

### FC/018/24 Climate partnership

Representatives of the Bude Climate Partnership and the Climate Jury attended the meeting. It had been reported that good feedback had been received from the Environment Agency regarding the recent community meeting held at the Falcon Hotel. The recommendations of the Jury were presented. Requests of BSTC from the jury were 3 fold being:

- that BSTC facilitate a meeting for the wider community to discuss the recommendations, to be held within 6mths.
- that BSTC receive Budehaven School Climate Jury recommendations.
- that BSTC hold an extraordinary Full Council meeting within 3mths to receive the Climate Jury recommendations.

Resolved: That BSTC hold an extraordinary Full Council meeting with 3mths, that BSTC receive the Budehaven school jury recommendations and that BSTC agree to help facilitate a meeting for the wider community with 6mths.

### FC/019/24 To receive the Mayor's Report

The Mayor had attended the community meeting of the Bude Climate Partnership / Jury and had followed this up with a joint meeting of the Bude Town Team and the Climate Partnership to discuss the Town Team governance arrangements.

### FC/020/24 To note any reports from Cornwall Councillors

C Cllr La Broy reported that CC funding for the Astro turf / lighting at Budehaven School had been awarded. He would be attending an informal meeting with representatives of the Bude Golf Club to discuss the ongoing works to the course. He had attended a meeting of the Bude CCTV group, who had offered to fit a camera to look at Foyer public conveniences using funding recently received from BSTC. He would be meeting with Connect Bude and the CC portfolio holder for transport to discuss transport to local health facilities. A meeting had taken place at Cavanna homes site to discuss the replacement of the Mill Stone. He discussed pedestrian crossing in Stratton and the upgrade of Rodds Bridge, the dredging and reinforcement of the canal wall and complaints from residents re: odour from the treatment works. Cllr La Broy took questions from the floor.
